Thursday, January 12, 2012 10:00 a.m.	EPRG members submit their comments/questions on each application electronically to MAG staff.
Thursday, January 19, 2012 9:00 a.m. MAG Cholla Room	Applicant Presentations to the MAG EPRG. No powerpoint presentations.
Thursday, February 2, 2012	Applicants receive comments from EPRG to make changes to their application. Submit project applications to State Historic Preservation Office (SHPO) for review.
February 2 – March 2, 2012	MAG staff conducts site visits and makes recommendations to improve applications. MAG distributes signature page for inclusion in final application.
Thursday, March 22, 2012 by 10:00 a.m.	Applicants re-submit one revised project application and one PDF copy of the application on a CD to MAG (with changes made from the EPRG and MAG comments). No late applications will be accepted.
Thursday, April 5, 2012 by 10:00 a.m.	EPRG members submit their ranking scores electronically to MAG staff.
Thursday, April 19, 2012 - 9:00 a.m. MAG Agave Room	MAG EPRG ranks applications. MAG staff prepares information for approval by MAG committees.
Wednesday, May 9, 2012 – Noon (tentative date)	Ranked list of applications reviewed by MAG Management Committee for recommendation to the MAG Regional Council.
Wednesday, May 30, 2012 - 5:00 p.m. (tentative date)	MAG Regional Council reviews ranked list of applications to forward to ADOT.
Thursday, June 28, 2012 - 10:00 a.m.	20 copies of each Final Application are due to the MAG office. No late applications will be accepted. Electronic submissions (e-mails and facsimiles) will not be accepted.
July 10, 2012	Applications due to the Arizona Department of Transportation (ADOT) for review and evaluation by the Transportation Enhancement Review Committee (TERC). Submitted to ADOT by MAG staff.
August 24, 2012	TERC receives statewide applications to score
October 3-5, 2012	3-day TERC meeting.
November, 2012	Approval of TERC recommendations by the State Transportation Board.
