TO
ACCEPT THE CAVE CREEK CAREFREE TRANSPORTATION FRAMEWORK STUDY PREPARED BY THE
MARICOPA ASSOCIATION OF GOVERNMENTS AND TO COLLABORATE IN GOOD FAITH TO JOINTLY
AND/OR INDIVIDUALLY CONSIDER THE STUDY RECOMMENDATIONS WHERE APPROPRIATE AND
FEASIBLE.**

WHEREAS, each Council desires to provide transportation improvements that will enhance or preserve and not detract from the natural and social character of the area; and

WHEREAS, each Council promotes a balanced transportation system that provides adequate capacity for a convenient access to vehicle, transit, bicycle/pedestrian, and equestrian travel modes; and

WHEREAS, each Council supports the development of transportation related projects that encourage tourism and promote economic prosperity; and

WHEREAS, each Council supports transportation projects that are fiscally responsible and preserve existing infrastructure; and

WHEREAS, each Council desires to improve the safety of the transportation system for all travel modes; and

WHEREAS, the Councils have demonstrated their resolve to work together by means of an Intergovernmental Agreement to jointly fund the design and construction of bicycle lanes on Cave Creek Road, Tom Darlington Drive and Pima Road,



Section 2: The Councils authorize the Town Manager/Administrator to collaborate in good faith to jointly and/or individually secure the funding necessary for the Council to carry out the study recommendations in a timely manner where appropriate and feasible.






