Federal Regulations

Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) require:

- The TIP is a guide to transportation investments within our region.
- All Federally funded projects.
- All regionally significant projects.
- Provide project detail (design concept and scope) to permit air quality analysis.
- Updated at least every four years.

Local projects like residential streets are NOT in the MAG TIP.




FY 2011-2015 TIP Projects

- 20 "other" projects




Funding for FY 2011-2015 TIP Projects

n Project Funding = \$6.9 Billion




Street & Highway Projects
