**EXECUTIVE SUMMARY**

On any given night, 5,631 people experience homelessness throughout the Region. This is according to the annual Point-In-Time (PIT) Count. On February 24, 2015, more than 300 volunteers counted and surveyed homeless men and women staying in shelters and sleeping on the street. The purpose was to collect data providing a one-night snapshot of the number of people experiencing homelessness in the region. The PIT Count, coordinated by MAG, municipalities, and regional street count coordinators is part of a national effort to identify the number of individuals and families experiencing homelessness. The count is a component of the application to the U.S. Department of Housing and Urban Development (HUD) for homeless assistance funding for 60 programs providing transitional housing, permanent supportive housing and services in the region.

The data is approximate. Moreover, despite fluctuations within the subpopulations, the total homeless population for the Region decreased by 11 percent since the 2014 count. The table below demonstrates a sample of the data collected.

Street count coordinators made some adjustments to the methodology for the 2015 PIT Count. The high-profile Super Bowl XLIX activities resulted in delaying the date of the count from the last week in January (mandated by HUD) to the last week in February to ensure that Super Bowl activities would not interfere with conducting the count. Furthermore, MAG partnered with the Homeless Management Information System (HMIS) to collect and analyze the PIT Count data from shelter programs. In previous years, MAG staff was responsible for tabulating and analyzing the data by hand. Details on the changes in methodology, limitations, and data analysis are discussed in the full report.

## INTRODUCTION

Homelessness occurs when individuals or households are unable to acquire or maintain affordable housing. In January 2014, “there were 578,424 people experiencing homelessness on any given night in the United States”<sup>1</sup>. This number comes from the PIT Count. The PIT Count is a HUD requirement and conducted on a single night in January every other year. During the count, communities must identify the sheltered and unsheltered *Families, Youth, Veterans, Chronically Homeless, and Individuals* experiencing homelessness in their community. Following the PIT Count, communities are required to submit their collected data through their Continuum of Care to qualify for the <sup>2</sup>McKinney-Vento Homeless Assistance Grants program. The PIT Count is important in establishing the dimensions of homelessness in a particular community and facilitates program administrators and policy makers in tracking the progress toward the goal of ending homelessness.

Maricopa County conducts the PIT Count every year to take a statistical snapshot of homelessness in the region. Every year the Maricopa Association of Governments (MAG) Continuum of Care (Continuum of Care)<sup>3</sup>, City of Phoenix, and participating municipalities facilitate the planning process of conducting the regional PIT count.

For the PIT Count in the region, hundreds of volunteers work in groups to count and identify unsheltered person’s experiencing homelessness. Simultaneously, shelters in the region connected to the local Homeless Management Information System (HMIS)<sup>4</sup> are

required to submit data on person’s staying in their shelter. For shelters in the region not connected to the local HMIS, MAG distributed a (non HMIS) Shelter Count form<sup>5</sup> to be filled out and returned. The Sheltered PIT count collects data from *emergency shelters, transitional housing, and Safe Haven* programs. Likewise, during the night of the count, homeless services providers must submit a Housing Inventory (HIC) that takes an inventory of bed and unit capacity of provider programs that offer beds and units dedicated to serving persons who are homeless and categorized by the same programs. The HIC and Sheltered PIT Count were designed to occur simultaneously to determine gaps in housing need.

The PIT Count is an effort to learn more about the individuals and families experiencing homelessness in Maricopa County in an effort to accomplish local and federal goals toward ending homelessness.

Based on local data collected during the 2014 Count, 5,918 people had experienced homelessness in Maricopa County, with 1,053 of them reported to be sleeping on the streets and 4,865 people in shelter. Of the total number of people counted, 1,819 were youth. With the completion of the 2015 PIT Count this report will summarize the background, research methodology, limitations, and results of the 2015 Homeless PIT Street and Shelter Count. The purpose of this report is to share the results of the count with the community, to provide a discussion of the methodology used, and to offer an analysis of the findings.

Data from the street and shelter count is collected to measure homelessness on a national and local scale and then published on the HUD Homeless Data Exchange (HDX) website. As part of the Annual Homeless Assessment Report (AHAR), the data is provided to Congress annually. The AHAR is used by HUD, Congress, additional federal departments, and the general public to understand the nature and extent of homelessness. The annual PIT data is also an important measure of local and national progress toward ending homelessness.

The PIT Count data also plays a critical role in the annual Continuum of Care Program Competition. HUD requires Continuums of Care to submit data and methodology reports and uses the information to evaluate the progress Continuums of Care are making to reduce homelessness. Reductions in homelessness are scoring factors that can influence Continuum of Care program funding awards.

### METHODOLOGY

Each Continuum of Care conducts a PIT Count utilizing HUD recommended practices and a variety of methodologies based on local demographic and geographic characteristics. Unique to the geographic area of the Count in Maricopa County is the size of the county. With 9,223 square miles<sup>6</sup> to cover for the PIT count, and 27 municipalities involved in the planning process, a combination of non-random sampling, extrapolation, and sample methods (based on common areas that homeless individuals congregate) were used.

The MAG Continuum of Care includes three surveys<sup>7</sup> in the count to identify geographic and demographic data. There is an in-person interview with a brief survey for persons unsheltered; an observation survey for persons unsheltered but not approachable; and a survey

for shelters to take of clients on the night of the count.

### VOLUNTEERS

For the 2015 PIT Count, MAG developed an online form for volunteers (public) to sign up and be assigned teams of two-three people. City of Phoenix service providers are required under contract to participate and those volunteer outreach professionals are assigned to high density areas like downtown Phoenix. For the 2015 Count, there were more than 300 volunteers, which is the highest number the count has ever had.

### MOBILE APPLICATION

HUD introduced a PIT Mobile Application for the 2015 PIT Count. The mobile application was designed as an alternative to paper surveys to determine data in 'real time' via a 'data center'<sup>8</sup>. There was no cost associated with downloading or using the mobile application and the application could operate with or without a data connection. MAG coordinated with six groups, enabling one member per group to test use the application. The mobile application had three surveys; a shelter survey, an interview survey, and an observation survey. The mobile surveys did not match the paper surveys used by the MAG Continuum of Care and were not customizable. As a result, the mobile application was used as a trial to understand if the application makes the counting process and data analysis more efficient than using paper surveys. Feedback from the mobile application users proved that the usability of the application was user-friendly and efficient. Future use of the mobile application has not been determined.

### PREPARATION

Some improvements were made to the 2015 count. MAG developed a training video demonstrating how to identify someone

experiencing homelessness and how to approach that person safely. The training video is now being used to train outreach professionals who approach persons experiencing homelessness on a daily basis. MAG also designed volunteer name tags for identification purposes to facilitate a safe interview process.

Furthermore, trainings occurred between 4:00 p.m. and 8:00 p.m. in two hour time slots in Scottsdale, Mesa, Phoenix, and Glendale. Volunteers could choose the municipality they wanted to train and count in through the online volunteer form. The street count coordinator of each municipality was responsible for creating volunteer packets with copies of each survey, a map of the designated area that the volunteer would be counting in, a name tag, and further instructions for the morning of the count. For 2015, municipal street count coordinators initiated extending the time frame of the count in an effort to gain a more accurate count of families and youth since both subpopulations tend to be visible earlier or later in the day. All volunteers were advised to begin at 6:00 a.m. and were expected to end around 10:00 a.m. Valley locations operating as welcome centers offered bags of hygiene products or food in exchange for an interview and operated until 12:00 p.m. in an effort to reach out to families and youth experiencing homelessness.

### LIMITATIONS

While the PIT Count provides valuable information about homelessness in the community, there are limitations to keep in mind. This section will identify the limitations of the 2015 Count for the MAG Continuum of Care.

### GEOGRAPHY

The size of Maricopa County makes it difficult to identify all persons experiencing homelessness. Data collected and analyzed are a general representation of a one-night snapshot in the region.

### YOUTH, FAMILIES, AND POPULATIONS NOT COUNTED

At the federal level, HUD and the Arizona Department of Education (ADE) define a youth experiencing homelessness differently. According to the ADE, under the guidelines of the *McKinney-Vento Homeless Education Assistance Act*, a “youth experiencing homelessness” is someone who lacks “a fixed, regular, and adequate nighttime residence”.<sup>9</sup> This definition includes youth who are sharing housing due to economic hardship. According to HUD, a person is considered homeless if they are staying in a place that is not meant for human habitation.

HUD requires communities to count a person experiencing homelessness only if they fit under the HUD definition of homelessness. The ADE collects data on homeless youth in the education system through school homeless youth liaisons; however that data cannot be included in homelessness data submitted to HUD due to conflicting definitions of homelessness. Moreover, the youth subpopulation overlaps the family subpopulation since many homeless youth in the education system are a part of a family unit that is also experiencing homelessness. Identifying families experiencing homelessness is difficult to track for three reasons; many times families have a place for their children to stay during the week while kids are in school but are homeless on the weekends. Therefore homeless families are more visible during weekends; families living on the streets or in

their vehicles frequently try to hide their homelessness out of fear that parents will lose custody of their children. During the street count for safety reasons, volunteers are told to avoid searching for homeless individuals in automobiles or abandoned buildings, which are common areas for homeless families to seek refuge.

Unaccompanied youth under the age of 18 often try to stay under the radar because of concern that they will be forced to return to their parents or will be sent to foster care<sup>10</sup>.

In an effort to identify the homeless youth subpopulation that is not associated with a family or ADE liaison, MAG coordinated with homeless youth providers like Tumbleweed, HomeBase, and OneNTen to plan magnet events where the youth could come for food, services, and entertainment in exchange for participating in the Count. Youth providers used social media and outreach to build awareness of the magnet event<sup>11</sup>. This method was used for the first time in Maricopa County and will now be used in future Counts.

For individuals staying at a jail or hospital during the count who are otherwise homeless, are not counted since they are not considered homeless by the HUD definition during the time of the count. Furthermore, for individuals staying in Emergency Rooms (ER), due to confidentiality rules hospitals cannot disclose the housing status of patients in the ER. As a result, homeless individuals in the ER are not included in the Count data.

### PIT DATA

There are more people that experience homelessness over the course of the year than on a single night. PIT Counts tend to under-

represent short-term homelessness and over-represent individuals that have experienced homelessness for a long time.

### PARTICIPATION

Volunteers experienced more homeless persons refusing to participate in the survey count than in previous years. Respondents may choose to not participate for a variety of reasons. Some individuals may want to preserve their privacy, or do not consider themselves homeless. Some individuals may be clearly homeless on the date of the count but were unable to provide information due to mental illness or impairment. The Observation Survey is designed for situations where outreach workers or volunteers are unable to complete a survey. This form of data collection is subjective

### DATE

Based on HUD requirements, communities must conduct their Count within the last week of January; however there are exceptions. If a major event occurs during this time that has the potential to adversely affect the data, the community may apply to HUD seeking approval to move the date of the count to the last week in February. For the 2015 count, it was brought to the attention of the PIT Count planning group that the *Super Bowl XLIX* activities which took place throughout several cities in the region, including Phoenix, Glendale, and Scottsdale, may impact the results of the count. Although the game would not occur on the actual day of the count, the anticipated activities were expected to draw in considerable traffic, resulting in closures in downtown Phoenix and Glendale. The MAG Continuum of Care sent a request to HUD to move the date of the count to the last week in February. The request was approved and the annual PIT Count took place on the morning of February 24, 2015.

### RECLASSIFICATION OF DATA

In 2014, homeless data from the Men's Overflow Emergency Shelter (MOS) and

adjacent East Lot was categorized as *sheltered* data, however, for the 2015 count, homeless data from the East Lot was categorized as *unsheltered*<sup>12</sup>. The change in how data was categorized resulted in 251 individuals categorized as unsheltered instead of as in shelter. The change in how these individuals were categorized was recommended by the street count planning group because the group felt that it would be more accurate to count people sleeping in a parking lot as unsheltered. This translates to a superficial rise in the unsheltered homeless population.

#### HOMELESS MANAGEMENT INFORMATION SYSTEM (HMIS)

Historically, the Maricopa HMIS Project has pulled PIT count data for the HMIS participating sheltered count and MAG staff has analyzed PIT Count data by hand. As part of the greater Phoenix region's growing efforts in planning the annual PIT Count, MAG coordinated with HMIS for PIT Count data analysis. The transition to use HMIS to analyze the data and de-duplicate data may present more accurate results than previous years. Furthermore, the data from HMIS provided more accurate answers to survey questions such as documenting chronically homeless and veteran status. Having this data available in HMIS will help for future research on how the homeless migrate back and forth from shelter to the streets.



“Structural facility issues which were cost prohibitive to repair necessitated the closure of the MOS facility. The facility was closed on March 31, 2015 following completion of a six month phase-out plan, which gradually reduced service capacity. The parking lot adjacent to the facility will remain open until May 15, 2015, at which point indoor, low demand shelter services will be available for 260 individuals across the street from the current site at the Human Services Campus. A supervised outdoor area will also be available for additional individuals.”

## DATA ANALYSIS

The PIT Count is a critical source of data intended to geographically and demographically represent a general snapshot of persons who are experiencing homelessness in a region. The shelter count captures a snapshot of individuals and families in shelter at the time of the count. The street count captures a snapshot of individuals and families who were staying in locations not meant for human habitation at the time of the count. The following section will discuss data elements of the count in greater detail.

Figure 1: Maricopa County Total Homeless Population from 2013-2015\*.

Figure 1 demonstrates the three-year trend in the region’s total homeless population, total unsheltered population, and total sheltered population from 2013 to 2015. The Sheltered population includes Emergency Shelters (ES)<sup>13</sup>, Domestic Violence (DV) Shelters, and Transitional Housing (TH)<sup>14</sup>. While the overall homeless number has remained relatively stable, the 2015 numbers show a slight 5 percent decrease from 2014 and a slight 4 percent decrease from 2013.

For a municipal breakdown of the unsheltered total, figure 2 below identifies the total unsheltered count for each municipality that reported data.

Figure 3: 2015 Sheltered and Unsheltered Homeless Populations by Gender\*.




Figure 3 depicts the gender of all persons<sup>15</sup> identified as homeless on February 23, 2015. For the 2015 Count HUD was seeking data on individuals that identified as Transgender. During the count, eight persons identified as Transgender and five of the eight persons were unsheltered.

Figure 4: 2015 Sheltered and Unsheltered Populations by Race\*.




Figure 4 shows the ethnicities of the sheltered and unsheltered homeless populations for 2015. According to Figure 4, 46% of the homeless population was identified as sheltered and Caucasian which is the largest racial group. Individuals that identified as Black or African American in shelter accounted for 22 percent of the total homeless population.

Figure 5: 2015 Homeless Population by Hispanic or Latino Origin\*.




Figure 5 shows the sheltered and unsheltered populations by Hispanic or Non-Hispanic origin. Based on Figure 5, 4 percent of the total homeless population identified as unsheltered and Hispanic and 19 percent of the total homeless population identified as sheltered and Hispanic. In comparison to 77 percent of the total homeless population that identified as Non-Hispanic, the Hispanic homeless population is small, which could be a positive factor in outreach efforts, since minority homeless populations may have a language barrier.

Figure 6: Subpopulations of Homeless\*.




Figure 6 shows the percentage and number by housing status for the various subpopulations that HUD requires data collection on. According to Figure 6, victims of Domestic Violence (DV) account for 10 percent of the total homeless population, and 9 percent of the DV subpopulation was identified as sheltered on the date of the count. In comparison, the subpopulations for individuals with Substance Abuse Disorder (SAD), Serious Mental Illness (SMI), Chronic Homelessness, or Veteran Chronic Homelessness, have a higher percentage that identified as unsheltered on the date of the Count.

Figure 7: 2015 Sheltered and Unsheltered Chronically Homeless Families and Singles\*.




Figure 7 expresses the unsheltered and sheltered status of chronically homeless families and individuals from 2013 to 2015. Based on Count data, since 2013 efforts to house chronically homeless families has improved from 4 chronically homeless unsheltered families in 2013 to 0 chronically homeless families in 2015.

Figure 8: 2015 Sheltered and Unsheltered Veterans\*.




Figure 8 depicts the subpopulations of Veteran families and Veteran singles that identified as unsheltered or one of the three main shelter categories. According to Figure 8, Veteran families that identified in the Count were housed in Transitional Housing or Emergency Shelter.

Figure 9: 2015 Homeless Veteran Population by Gender.




Figure 9, shows the homeless Veteran population by gender. According to Figure 9, 95 percent of the homeless Veteran population identified as male and 5 percent identified as female.

Figure 10: 2015 Ethnicity of Homeless Veterans Population.






Figure 10 shows the ethnicities of the Veteran population for 2015. Based on Figure 10, 68 percent of Veterans identified as Caucasian and 26 percent of Veterans identified as Black or African American. The remaining Veteran population identified as 6 percent American Indian, with one person identifying as Asian.

Based on Figure 11, the homeless youth population was identified in either Emergency Shelters or Transitional housing. The majority of the youth population experiencing homelessness, 91 percent, was in Emergency Shelter and the remaining 5 percent were in Transitional Housing. According to the data collected, there were no youth under 18 years identified as homeless on the street. Data<sup>16</sup> on the overall count of youth experiencing homelessness<sup>17</sup> in the valley is depicted in figure 12. The sheltered data in figure 12 represents homeless youth 25 years of age or younger; however the unsheltered data is only representative of youth between 18 and 24 years of age.

“Beginning in 2015, CoCs must report data on persons in Youth Households, including the gender, race, and ethnicity for parenting youth and unaccompanied youth. Parenting youth are youth who identify as the parent or legal guardian of one or more children who are present with or sleeping in the same place as that youth parent, where there is no person over age 24 in the household. Unaccompanied youth are persons under age 25 who are not presenting or sleeping in the same place as their parent or legal guardian, including: A. single youth; B. youth couples; and C. groups of youth presenting as a household.”

## CONCLUSION

The 2015 PIT Count had a strong volunteer participation thanks to the planning efforts of the MAG Continuum of Care and participating municipalities. Through collaboration with HMIS, the data were collected and analyzed to communicate a general snapshot of homelessness in the region. In comparison to data from 2014, the shelter count decreased by 11 percent and the street count increased by 22 percent. Local experts attribute this shift to the re-categorized data of the East Lot. Overall, the number of persons experiencing homelessness has decreased in the last three years. Moreover, decreases in data were identified for various subpopulation subcategories for 2015 data. The data presented in this report represents one night in the region and cannot fully determine and identify the various populations in the region experiencing homelessness. The materials in the appendix are meant to support data and other planning efforts of the 2015 PIT Count. It is important to consider the results of the 2015 count within the context of local efforts to move the chronically homeless and Veteran populations out of homelessness through the provision of housing and support services. Furthermore, the community has worked diligently to ensure that homeless individuals originally seeking shelter at the MOS and East lot are quickly rehoused through a partnership of St. Vincent De Paul and the Lodestar Day Resource Center.

This report was developed using data to recognize that homelessness is a complex, recurring issue in the region. Planning efforts for the annual PIT Count have increased each year as more resources are made available, and recruitment efforts for volunteers continue to improve. In addition, the partnership between municipalities, the MAG Continuum of Care, and PIT Count Coordinators is growing stronger in an effort to unify planning efforts. With the coordination, planning efforts, and initiative of the MAG Continuum of Care and supporting agencies, the region will continue to collaborate on efficient and effective approaches to provide housing and end and prevent homelessness regionally.

### Appendix E: Glossary of terms

#### Continuum of Care (Continuum of Care)

An administrative geographical unit; the local or regional body that coordinates funding and services for homeless people.

#### Emergency Shelter

any facility, the primary purpose of which is to provide temporary or transitional shelter for the homeless in general or for specific populations of the homeless.

#### PIT Count (PIT)

Continuums of Cares are required to conduct an annual count of homeless persons who are sheltered (i.e. persons in emergency shelter, transitional housing, and Safe Havens on the night of the count) and unsheltered.

#### Homeless

An individual who lacks a fixed, regular, and adequate nighttime residence; as well an individual who has a primary nighttime residence that is a supervised publicly or privately operated shelter designed to provide temporary living accommodations, an institution that provides a temporary residence for individuals intended to be institutionalized; or a public or private place not designed for, or ordinarily used as, a regular sleeping accommodation for human beings.

#### Household

All the people who occupy a housing unit. A household includes the related family members and all the unrelated people, if any, such as lodgers, foster children, wards, or employees who share the housing unit. A person living alone in a housing unit, or a group of unrelated people sharing a housing unit such as partners or roomers, is also counted as a household.

#### Housing Inventory Count (HIC)

The HIC is a snapshot of a Continuum of Care's housing inventory on a single night during the last ten days in January. It should reflect the number of beds and units available on the night designated for the count that are dedicated to serve persons who are homeless. Beds and units included on the HIC are considered part of the Continuum of Care homeless system.

#### Transitional Housing

A project that has as its purpose facilitating the movement of homeless individuals and families to permanent housing within a reasonable amount of time (usually 24 months). Transitional housing includes housing primarily designed to serve deinstitutionalized homeless individuals and other homeless individuals with mental or physical disabilities and homeless families with children.

#### McKinney-Vento Homeless Assistance Grants

The largest federal investment in homeless assistance, and is responsible for funding many local shelter and housing programs.

#### U.S. Department of Housing and Urban Development

Established in 1965, HUD's mission is to increase homeownership, support community development, and increase access to affordable housing free from discrimination. To fulfill this mission, HUD will embrace high standards of ethics, management and accountability and forge new partnerships — particularly with faith-based and community organizations — that leverage resources and improve HUD's ability to be effective on the community level.




Appendix G: HUD Mobile Application
