1. Call to Order

The Regional Community Partners Board of Directors meeting was called to order by Chair Hallman at 12:02 p.m. Chair Lopez Rogers stated that public comment cards were available for those members of the public who wish to comment. Transit tickets were available from Valley Metro for those using transit to come to the meeting. Parking validation was available from MAG staff for those who parked in the parking garage.

2. Call to the Audience

Chair Lopez Rogers noted that, according to the MAG public comment process, members of the audience who wish to speak are requested to fill out the public comment cards. She stated that there is a three-minute time limit. Public comment is provided at the beginning of the meeting for items that are not on the agenda that are within the jurisdiction of MAG, or non-action agenda items that are on the agenda for discussion or information only. Chair Lopez Rogers noted that no public comment cards had been received.

3. Approval of the September 17, 2012 MAG Regional Community Partners Board of Directors Meeting Minutes

Mayor Lane moved to approve the September 17, 2012 MAG Regional Community Partners Board of Directors meeting minutes. Mayor Barney seconded the motion and the motion carried unanimously.

4. Accept Funding for the Age-Friendly Cities Initiative to Support Aging Services Planning

Amy St. Peter, Human Services and Special Projects Manager, stated on October 10, 2012, Grantmakers in Aging and the Pfizer Foundation announced a \$150,000 grant award to Regional Community Partners to participate in the Age-Friendly Cities Initiative. Ms. St. Peter added the region's proposal included cash match commitments from the following project partners: Tempe

Community Council \$5,000; Area Agency on Aging \$1,000; Duet \$300; Benevilla \$300; and Sun Health \$15,000 and all contributions will support the implementation of the Age-Friendly Cities Initiative in this region. She added the project will include technical assistance to three village pilot projects, an aging-in-place conference, a website for older adults, and an outreach video. Ms. St. Peter added this region was selected as one of five in the country to participate in the initiative. Ms. St. Peter noted this item is to accept the grant and recommend approval of an amendment to the MAG 2012 Unified Planning Work Program and Annual Budget (UPWP) increasing the budget for RCP by \$171,600.

Chair Lopez Rogers thanked Ms. St. Peter and asked if there were any questions or comments. There were none.

Mayor Barney moved to approve accepting the funding from the Grantmakers in Aging and Pfizer Foundation, Tempe Community Council, Area Agency on Aging, Duet, Benevilla, and Sun Health grant to support the Age-Friendly Cities Initiative and recommend approval of the budget amendment to the FY 2013 MAG Unified Planning Work Program and Annual Budget to add this grant award and cash match commitments for an increase to the overall budget of \$171,600. Mayor Lane seconded the motion and the motion carried unanimously .

SUBJECT: ACCEPT FUNDING FROM PARTNERS FOR LIVABLE COMMUNITIES TO SUPPORT AGING SERVICES PLANNING

The FY 2014 MAG Unified Planning Work Program and Annual Budget (UPWP) was approved on May 22, 2013. On June 20, 2013, a \$3,000 grant from Partners for Livable Communities was awarded to Regional Community Partners (RCP) for work on the City Leaders Institute on Aging in Place. This region was selected as one of five communities in the country to participate in this national pilot project. The MetLife Foundation is providing \$3,000 grants to each of the communities selected. As part of the Institute, the region will develop strategies to meet the transportation needs of older adults in the pilot project areas in Phoenix, Tempe, Scottsdale, and the Northwest Valley. This item is to accept this grant and recommend approval of an amendment to the MAG 2014 Unified Planning Work Program and Annual Budget (UPWP) increasing the budget for RCP by \$3,000.

The City Leaders Institute on Aging in Place supports the implementation of the MAG Regional Aging in Community Network. The Network was designed to connect older adults to opportunities to be meaningfully involved in their communities. Extensive community engagement identified transportation as one of the foremost concerns of older adults. This project will leverage current assets to enhance the access and options older adults have to travel throughout the region. This project has also received funding from the Virginia G. Piper Charitable Trust and the Pfizer Foundation through Grantmakers in Aging as part of a national pilot project, Community AGEnda. Funding from this grant will be used to support training, technical assistance, and community outreach for the region's participation in the City leaders Institute on Aging in Place.
