The four agencies with the largest funding requests were asked by the committee to adjust their requests. The resulting arterial ITS funding requests by MAG, City of Mesa, City of Tempe and Maricopa County have been adjusted. The complete list of projects is shown on Attachment One. Action is requested to recommend the list of projects for inclusion in the FY2008-FY2012 TIP.
