Overview

FTA Section 5310 Enhanced Mobility of Seniors and Individuals with Disabilities Program grant makes funding available for capital and operating expenses to support the provision of transportation services to meet the specific needs of seniors (aged 65 and over) and individuals with disabilities when public transportation is insufficient, unavailable, or inappropriate.

Please note, “it is not sufficient that seniors and individuals with disabilities are merely included (or assumed to be included) among the people who will benefit from the project” (FTA C 9070.1G, pg. III-9).

FTA Section 5310 Enhance Mobility of Seniors and Individuals with Disabilities

- **Federal awards program**
- **Eligible applicants:**
 - Private nonprofit (PNP) organizations
 - Public agencies-where no viable PNPs available
 - Tribal governments
- **Eligible Populations**
 - Agencies serving older adults (65+)
 - Agencies serving persons with disabilities




Programming Guidelines

- Federal guidelines allow large Urbanized Areas (UZAs), with populations over 200,000, to directly administer Section 5310 funds.
- In 2013, the region requested a change to the City of Phoenix Public Transit Department (PTD) as the Designated Recipient for the Phoenix-Mesa UZA.
- In 2015, the programming responsibilities moved to the Maricopa Association of Governments (MAG) in coordination with the City of Phoenix Public Transit Department.

Regional Section 5310 grant

- Phoenix/Mesa Urbanized Area
 - City of Phoenix Designated Recipient
 - Application process coordinated through Maricopa Association of Governments
- Avondale/Goodyear Urbanized and Rural Areas
 - Arizona Department of Transportation (ADOT) Designated Recipient
 - Application process is coordinated through ADOT

- 5310 Non-Urbanized (ADOT DR)



Funding

- Based on 2017 funding apportionment, approximately \$3 million for the Phoenix-Mesa Urbanized Area
- Not less than 55 percent of program funds must be used on capital or “traditional” 5310 projects.
- The remaining 45 percent, less 10 percent administration fee, is for other “nontraditional” projects to include projects eligible under the **former 5317** New Freedom program, described as:
 - “Other” Capital and operating expenses for public transportation services and alternatives **beyond those required by the ADA**, designed to assist individuals with disabilities and seniors.
