
JARC Program Updates

Program Goals: To improve access for low-income persons to jobs and job-related services

- MAG Lead Agency
- Emphasis on:
 - Coordination and outreach (30%)
 - Target Population (30%)
 - Performance Metrics (20%)
 - Meeting Program Intent (20%)

JARC Program Updates

- Call for projects include FY 2014 and 2015
 - Up to 2 years funding available
- Funding Amounts
 - Minimum request - \$30,000
 - Maximum Request - \$200,000 for single agency application/\$400,000 for multi-agency application


